A RESOLUTION FOR THE BUDGET APPROVAL OF THE SANGGUNIANG KABATAAN OF BARANGAY SAN ISIDRO, SANTIAGO CITY FOR THE CELEBRATION OF LINGGO NG KABATAAN OR BUWAN NG KABATAAN (BNK) 2024 WORTH TWENTY THOUSAND PESOS (20,000).

WHEREAS, the Republic Act No. 10742 also known as the Sangguniang Kabataan Reform Act of 2015 provides in Chapter VI Section 33 paragraph (a) states that every province, city, municipality and barangay shall conduct an annual activity known as the Linggo ng Kabataan on the week where the 12th of August falls to coincide with the International Youth Day. The SK, in the case of barangay, and the respective LYDC in cooperation with the Pederasyon ng SK, in the case of province, city and municipality, shall take the lead in this observance.

WHEREAS, the Sangguniang Kabataan of Barangay San Isidro will conduct a three days celebration starting on August 24, 2024 to August 26, 2024 (Saturday-Monday).

WHEREAS, the Sangguniang Kabataan of Barangay San Isidro will conduct activities that will strengthen the bond of the youths of Barangay San Isidro through interactive activities that creates impact mentally, physically and emotionally.

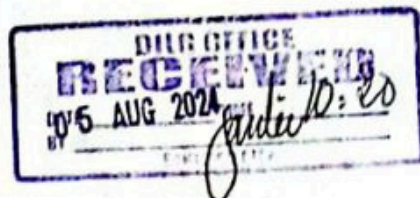




