A RESOLUTION REQUESTING THE SANGGUNIANG BARANGAY TO ADOPT AND TO INCLUDE THE THREE (3)- YEAR COMPREHENSIVE BARANGAY YOUTH DEVELOPMENT PLAN IN THE BARANGAY PRIORITY INVESTMENT PROGRAMS/PROJECTS/ACTIVITIES AND/OR SERVICES OF SAN ISIDRO, SANTIAGO CITY.

WHEREAS, pursuant to the mandates of Republic Act No. 10742, known as the SK Reform Law, the Sangguniang Kabataan of each barangay shall "formulate a three (3)- year rolling plan, which shall serve as basis in the preparation of the Annual Barangay Youth Investment Development Plan (PYDP) and other Local Youth Development Plans in every municipal, city, provincial level, as the case may be;

WHEREAS, the Sangguniang Kabataan council of San Isidro, Santiago City, through its SK Chairman, Sponsored Resolution No. 15 Series of 2024 titled A Resolution Requesting The Sangguniang Barangay To Adopt And To Include The Three (3)- Year Comprehensive Barangay Youth Development Plan as integral part thereof;

WHEREAS, every SK Chairman, together with SK council, is mandated to formulate their Comprehensive Barangay Youth Development Plan (CBYDP) within the periods prescribed by law;

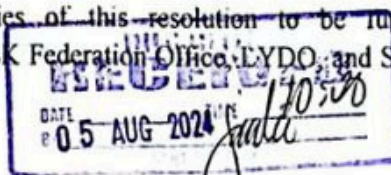
WHEREAS, on June 26, 2024, the Sangguniang Kabataan Council of Barangay San Isidro, Santiago City conducted a Special Session to craft and formulate a Three (3)-year Comprehensive Barangay Youth Development Plan in accordance with the City Youth Development Plan and the Philippine Youth Development Plan;

WHEREFORE, on motion of Hon. Kzchin Lynard Garcia, and duly seconded by Hon. Korina Rigor, be it;

RESOLVED, AS IT IS HEREBY RESOLVED, to request the Sangguniang Barangay to adopt and include the Three (3)- Year Comprehensive Barangay Youth Development Plan In The Barangay Priority Investment Programs/Projects/Activities And/Or Services Of San Isidro, Santiago City.

RESOLVED FURTHER, to attach herewith the Three (3)- Year Comprehensive Barangay Youth Development Plan (CBYDP) for reference and information.

RESOLVED FINALLY, to let copies of this resolution to be furnished the Department of Interior and Local Government, SK Federation Office, LYDO, and Sangguniang Barangay Secretary.
