A RESOLUTION FOR THE BUDGET APPROVAL OF THE SANGGUNIANG KABATAAN OF BARANGAY SAN ISIDRO, SANTIAGO CITY FOR THE RELEASE OF THE SANGGUNIANG KABATAAN MEMBER, TREASURER, AND SECRETARY HONORARIUM FOR THE MONTH OF JUNE AMOUNTING (6,021.00) PESOS ONLY.

WHEREAS Section 4 of RA Section 4 of RA No. 11768, amending Section 16 of t No. 11768, amending Section 16 of the SK Reform Act the SK Reform Act of 2015 (RA of 2015 (RA No 10742), provides the following: "The [SK] members, including the [SK] treasurer and secretary, shall receive a monthly honorarium, chargeable against the [SK] funds, in addition to any other compensation provided by this Act and shall be granted at the and shall be granted at the of every regular monthly [SK] meeting: Provided , That the monthly honorarium shall not exceed the monthly compensation received by their [SK] chairperson: Provided, further , That not more than twenty-five percent (25%) of the [SK] funds shall be allocated for personnel services. The DBM shall issue the necessary guidelines implementing this provision."

WHEREAS this resolution aims to recognize the vital role of the youth in nation building, acknowledges that the Sangguniang Kabataan is an important vehicle for youth involvement in policy-and decision-making process of the government and, thus, seeks to maximize this institution as a partner in the barangay's equitable and sustainable socio-economic development.

WHEREAS the Sangguniang Kabataan members, SK Secretary and SK Treasurer shall be granted honoraria based on the following criteria.

- a. They shall attend the regular session of the Sangguniang Kabataan as required in and mandated by the SK Reform Act;
- b. They shall receive P669.00per month; the release of the honoraria shall be supported by minutes of meetings and attendance sheets duly certified by the SK Secretary and duly attested by the SK Chairperson, as well as other necessary documents required under government accounting and audit rules and regulations.

WHEREAS the Sangguniang Kabataan council allocated six thousand and twenty one pesos (6,021.00) for the honorarium of the SK Members, SK Secretary, and SK Treasurer in the month of June which will be charged in the 25% of the SK Funds.

NOW THEREFORE, be it resolved, and it is hereby resolved to confirm the release of the SK Honorarium to SK members, SK Secretary, and SK Treasurer.

RESOLVED FURTHER, that copy this resolution given to Barangay Secretary and SK Secretary for his copy furnished the City Local Government Operations Officer and the Local Youth Development Office of Santiago City, Isabela for their information and records.
