A RESOLUTION FOR THE BUDGET APPROVAL OF THE SANGGUNIANG KABATAAN OF BARANGAY SAN ISIDRO, SANTIAGO CITY FOR BALIK ESKWELA SCHOLARSHIP PROGRAM, TO BE GRANTED TO COLLEGE AND SENIOR HIGH SCHOOL STUDENTS OF BARANGAY SAN ISIDRO CHARGEABLE TO THE SK FUND.

WHEREAS, SK COUNCIL will be giving Educational Assistance for all student who are enrolled this year 2024 whether it is Public or Private. It aims to enable learners to pursue educational with the educational support.

WHEREAS, SK Program "BALIK ESKWELA SCHOLARSHIP" will be given to students who will comply requirements such as Certificate of Grades, Xerox Copy of ID, and Barangay Indigency and pass the screening.

WHEREAS, the amount will be given in the Scholarship will be chargeable to the SK Fund. The 15 qualified College students will receive Two Thousand Pesos (2,000) each and 10 qualified Senior High School student will receive One Thousand pesos (1,000) each, with a total of Forty Thousand Pesos (40,000). The said scholarship will be effective only in one semester and only if the student will be able to apply for this program.

WHEREAS, the Scholarship program will be directed qualified students. This aims to lessen the burden of the student when it comes in financial difficulty.

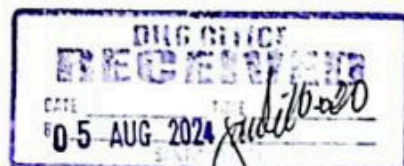
