SANGGUNIANG KABATAAN RESOLUTION

A RESOLUTION APPROVING THE DISBURSEMENT OF FUNDS FOR TRAVELING EXPENSES AMOUNTING TO FOUR THOUSAND FOUR HUNDRED NINETY FIVE PESOS (4,495.00) AND FIDELITY BOND PREMIUMS AMOUNTING TO TWO THOUSAND PESOS (2,000.00) IN CONNECTION WITH THE OFFICIAL ACTIVITIES AND FINANCIAL RESPONSIBILITIES OF THE SANGGUNIANG KABATAAN OF BARANGAY SAN ISIDRO, SANTIAGO CITY.

WHEREAS, the Sangguniang Kabataan of Barangay San Isidro is committed to participating in official activities, and programs relevant to youth development and governance, which necessitate traveling by the SK Officials and members.

WHEREAS, under existing regulations, SK Officials handling public funds, including the SK Treasurer, are required to be covered by a Fidelity Bond to protect public funds from possible risks;

WHEREAS, the Sangguniang Kabataan has allocated funds in its budget to cover both the traveling expenses for official functions and the payment of Fidelity Bond premium.

WHEREAS, the timely disbursement of these funds is necessary to ensure the efficient operation of the Sangguniang Kabataan and compliance with the requirements of the Commission on Audit and other governing bodies;

NOW THEREFORE, on motion of SK Chairperson, Hon. Marvin B. Estrada and duly seconded by the SK Members, be it:

RESOLVED, as it is hereby resolved, to approve the disbursement of the allocated funds for traveling expenses in the amount of Four Thousand Four Hundred Ninety-Five Pesos (4,495.00) to cover the official travels of the Sangguniang Kabataan Council of Barangay San Isidro for the period covering October 10, 2024.
