A RESOLUTION FOR THE BUDGET APPROVAL OF THE SANGGUNIANG KABATAAN OF BARANGAY SAN ISIDRO, SANTIAGO CITY FOR THE SK INNOVATION PROJECT ENTITLED "SANGGUNIANG KABATAAN CHECKLIST" WORTH TWO THOUSAND (2,000) PESOS ONLY.

WHEREAS, the Sangguniang Kabataan of Barangay San Isidro, Santiago City ensure the implementation of policies, programs, and projects as contained in the annual Barangay Youth Investment Programs, in coordination with the Sangguniang Barangay and the City Youth Development Council.

WHEREAS, the Sangguniang Kabataan wishes to implement the "SK Checklist" as an innovation to improve the good services of Teen Center Facility and to accommodate large numbers of youth.

WHEREAS, the Sangguniang Kabataan of Barangay San Isidro allocate a budget for the ALRIGHTS Teen Center worth Two Thousand (2,000) pesos only in the Annual Barangay Youth Investment Program.

WHEREAS, the "SK Checklist" will serves as a directory list of all youth in the barangay and it contains their personal information for future purposes.

WHEREAS, the "SK Checklist" will also serve as a basis for the pointing system for the identifying and awarding the "Outstanding Kabataan ng Barangay San Isidro".

WHEREAS, on June 26, 2024, the Sangguniang Kabataan Council of Barangay San Isidro, Santiago City conducted a Regular Session to formulate the said resolution and to approve therein;

THEREFORE, on motion of Hon. Kzchin Lynard Garcia, and duly seconded by Hon. Princess Angel Gawat, that the available fund for the ALRIGHTS Teen Center, be it:

RESOLVED, AS IT IS HEREBY RESOLVED, to request the Sangguniang Barangay to adopt and approve the said resolution and for the withdrawal and availability of the fund;

RESOLVED FINALLY, to let copies of this resolution to be furnished the Department of Interior and Local Government, SK Federation Office, LYDO, and Sangguniang Barangay Secretary.
